Motions for Expungement will not be accepted by the Clerk's Office unless each U.S. Post Office money order is issued in the correct amount and made payable to the proper agency as indicated below:

Additionally, in DWI cases a \$50 money order is needed made payable to the Department of Public Safety and Corrections.
